- The preparation and analysis of terrestrial and marine samples. The process typically involves the boiling of samples (30 litre boiler) before drying the samples in an oven and then grinding the samples using a small laboratory grinder internally. The samples are then analysed using an alpha and beta radiation counter and a gamma mass spectrometer. The Sample Preparation Room has an air extraction system which includes a carbon filter. The gamma mass spectrometer requires a cryogenic cooling system which includes an external 500ltr low pressure storage vessel containing nitrogen.
- The site requires an external 100 KVA diesel generator to provide power to the premises in the event of a power failure.
